## The New Primate of Korea

*The Most Reverend Paul Hwan Yoon*





Bishop Paul was born in Chung-ju, South Korea in 1938 and was baptized by Bishop Paul Burrough in 1952 and Confirmed by Bishop Chadwell in 1953.

He was ordained priest in 1967 by Bishop John Daly and consecrated Bishop by Archbishop Robert Runcie in 1987.

In 1962 he entered Soongsil University (Law) and in 1966 went to St. Michael's Seminary. Then in 1970 he attended the A.A. School of Architecture, London.

- 1976-1981 Rector: St. Michael's Seminary, Seoul
- 1972-1978 Lecturer: Songjun University (Dept Art)

- 1981-1987 Vicar: Church of the Annunciation
- From 1987 Bishop of Taejon

## KOREAN ANGLICAN CHURCH CENTRE IN LONDON

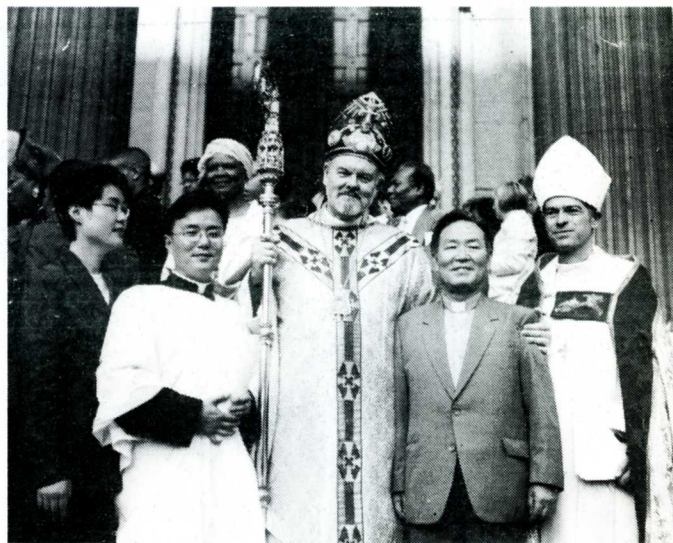
The English mission to Korea started when Archbishop Benson consecrated Bishop John Corfe in 1889 at Westminster Abbey, appointing him as the first bishop of Korea. Ever since then the people in this country faithfully supported the Korean Mission to take part in mission of Christ. We thank God for the growth of the Anglican Church in Korea and she has become a Province within the Anglican Communion.

Now many Koreans come to England, the mother country of the Anglican Communion for business, study and sightseeing. The estimated Korean population in England is about 40,000. Many of them reside in the greater London area. Most are temporary residents and stay in this country for 3-5 years. This is a wonderful opportunity not to be missed.

The Korean Anglican Church Centre is a new vision that will serve Korean Anglicans who visit this country. Helping them to have a more rewarding spiritual journey and to engage in mission to Koreans before they return to Korea. It is a wonderful opportunity to share with them the Christian gospel and something of the Christian heritage of this country.

The first step is taken. The Revd Paul Hang-sik Cho was ordained deacon on July 1st by the Bishop of London, by a Letter of Dimissory from the Bishop of Seoul. He is to serve his title at St Mary Magdalene, Munster Square London from 23rd July 2000. He will be working for the Korean Anglican Church Centre.

## ALL YOUR DONATIONS CAN BE WORTH MORE TO K.M.P. AT NO COST TO YOU

You may have heard that, from 6th April 2000, in order to encourage the valuable work of charities the Chancellor has made it easier for them to reclaim tax on the donations they receive.

Previously (except for Millennium Gift Aid where the limit was £100) only tax on large gifts of £250 or more and on payments made under deed of covenant could be reclaimed. Now when any taxpayer makes gifts, no matter what their size or frequency, the charity can claim and receive an extra 28 pence for every £1 donated. *(For the mathematically inclined the £1 received is considered to be net of basic rate tax of 22% i.e. equivalent to 78% so the charity can reclaim 22 on 78 which works out at 28% of the gift)*

All you need to do is to complete a simple Gift Aid Declaration. This only has to be done once. It does not commit you to a donation but covers all future donations of whatever size. It is very easy to arrange. All it does is give us permission to reclaim tax that you are already paying on the amount of your donations. You can cancel it at any time and should do so if you cease to be a taxpayer.

Almost everyone who pays tax pays enough to qualify. The only condition is that the total income tax you suffer should at least equal 28% of the charitable donations you make under all your Gift Aid Declarations. So it is not necessary to be a 22% or 40% rate taxpayer to be able to provide extra benefit for your favourite charities. Gift Aid Declarations are worthwhile for those whose highest rate of tax is 20% or 10% as well as for those paying at 22% or 40%.
